

**PRESS COMMUNIQUE**  
**Plan for Issues of Government Securities for Period August 2018 to June 2019**

The Bank of Mauritius, acting as agent of Government, will issue Government securities (Treasury Bills, Treasury Notes and Government of Mauritius Bonds) for the period August 2018 to June 2019 as per the indicative amounts specified below.

**A. Treasury Bills**

Treasury Bills of 91 days, 182 days and 364 days will continue to be issued until further notice. The range for the amount to be issued for the coming two months and the tender amount for the coming two weeks will be posted on the websites of the Ministry and the Bank of Mauritius. A communiqué detailing the maturity and the amount to be auctioned will be issued at least one day prior to the auctions.

**B. Three-Year Benchmark Treasury Notes**

Three-Year Treasury Notes (TN) for an aggregate nominal amount of Rs 22,000 million will be issued through auctions on a monthly basis as per dates specified in the table below.
