## **Salary Compensation 2025**

The purpose of this Circular is to inform you of the following approved rates of salary compensation to be paid in the public sector as from 1st January 2025:

Monthly Wage or Salary	Additional Remuneration per Month

Up to Rs 50,000	Rs 610
Above Rs 50,000	Nil
II. Part-tii	me Employees
Up to Rs 16,500	3.7% rounded to the next rupee and subject to a maximum of Rs 610
Above Rs 16,500 up to Rs 50,000	Rs 610
Above Rs 50,000	Nil

- 2. The Salary Compensation 2025 will be payable to the following:
  - (a) full-time employees in the public sector, i.e., the Civil Service, the Rodrigues Regional Assembly, Local Authorities and Parastatal & other Public Bodies;
  - (b) councillors under the Local Government Act;
  - (c) officers/advisers employed on contract;
  - (d) personal Drivers of Ministers and Constituency Clerks; and
  - (e) part-time employees in the Civil Service, Rodrigues Regional Assembly, the Local Authorities and Parastatal & other Public Bodies.

- 3. Moreover, the following beneficiaries will be eligible for a compensation at the same rate as the salary compensation payable to a **part-time employee** in the public sector:
  - (a) public service pensioners and beneficiaries of the Civil Service Family Protection Scheme;
  - (b) recipients of Compassionate Allowance under the Government Servants (Allowances) Regulations 1962;
  - (c) retired members of the National Assembly and Rodrigues Regional Assembly; and
  - (d) pensioners of Local Authorities and Parastatal Bodies.
- 4. The compensation 2025 should be paid to **the above beneficiaries** drawing a monthly salary, wage, retiring pension/compassionate allowance of up to Rs 50,000 in 2025 inclusive of additional remuneration, if any, for previous years.
- 5. Supervising Officers are kindly requested to:
  - (a) ensure that the salary compensation 2025 is paid to all eligible incumbents as from 01 January 2025; and
  - (b) relay the contents of this Circular to all public bodies falling under the aegis of their Ministries/Departments.
