PRESS COMMUNIQUE Issuance Plan of Government Securities for Period January 2026 to June 2026

The Bank of Mauritius, acting as agent of Government, will issue Government securities (Treasury Bills, Treasury Notes and Government of Mauritius Bonds) for the period January 2026 to June 2026 as per the indicative amounts specified below.

A. Treasury Bills

A communiqué detailing the maturity and the amount of Treasury Bills to be auctioned will be issued at least one day prior to the auctions. The range of the amount to be issued for the coming two months and the tender amount for the coming two weeks will be posted on the websites of the Ministry and the Bank of Mauritius.

B. Three-Year Benchmark Treasury Notes

Three-Year Treasury Notes (TN) for an aggregate nominal amount of Rs 11,500 million will be issued through auctions on a monthly basis as per dates specified in the table below:
