

STRATEGIC OVERVIEW

I. Mission Statement

- To make Mauritius cleaner, greener, environmentally-sustainable, climate change-resilient and a low greenhouse gas emission country
- To impart the culture of environmental conservation and protection to the citizens and all organisations
- To achieve a circular and green economy through waste segregation at source and promotion of resource recovery and recycling of waste
- To preserve public beaches through proper control, management and integrated coastal zone projects

II. Current Situation & Challenges

Addressing coastal erosion

- Mauritius as a Small Island Developing State (SIDS) is facing the consequences of extreme climate events including sea level rise. The sea level rise of 4.7 mm per year recorded in Mauritius exceeds the global average of 3.3 mm per year.
- Sea level rise and climate change, including intense cyclones, are accentuating coastal erosion in Mauritius and causing loss of prime beachfront. Numerous efforts are being undertaken to carry out coastal rehabilitation in order to safeguard the natural assets for the benefit of citizens and the tourism industry.
- In 2023, 1.6 km of eroded coastline from Bambous Virieux to Anse Jonchée were rehabilitated. Rehabilitation works are on-going over some 450 m of coastline at Bois des Amourettes.
- Services of consultants were retained to initiate preparatory works for the rehabilitation of some 19.5 km of eroded shoreline at 21 priority sites.
- The MoNatir mobile application has been launched in April 2024 on Earth Day. It provides vital and dynamic environmental information (e.g. Air Quality Index, environmental news and highlights).

Beach Management

- Upgrading and embellishment works, in line with Beach Management Plans, at Mont Choisy, Belle Mare and Flic en Flac public beaches have been successfully completed and works at La Prairie public beach are ongoing.
- 40 floating beach wheelchairs were acquired to facilitate access to the lagoon for people with disabilities.

Plastic Management

- There are currently 240 companies (227 in 2023) for the manufacturing/import of Biodegradable Single Use Products and 368 companies (322 in 2023) for the manufacturing/import of exempt plastic bags and/or biodegradable plastic bags.


- The moratorium for the Environment Protection (Control of Single Use Plastic Products) Regulations 2020 in respect of the ban on non-biodegradable single use plastic bowls, plastic cups and plastic trays is still in force up to 15 January 2025 in order to assist the industrial sector in the transition towards plastic free alternatives.
- The moratorium for Environment Protection (Banning of Plastic Bags) Regulations 2020 has been extended up to 31 August 2025, in order to align the definition of biodegradable plastic bag with the forthcoming Internationally Legally Binding Instrument to end plastic pollution that will contain an international definition of biodegradable plastic polymers.

Greening of the Public Sector

- The action plan for greening of the public sector approved by Government in March 2023 is being implemented.
- Dedicated cells have been set up in specific Ministries to pursue green initiatives in the following areas: supply chain and procurement, buildings and infrastructure, mobility and fleets, culture and behaviour and digital transformation.

Climate Change and Greenhouse Gas Emissions

- Mauritius is experiencing significant climate change impacts such as intense rainfalls, storm surges and recurrent flashfloods.
- Mauritius submitted its Nationally Determined Contributions to the Secretariat of the United Nations Framework Convention on Climate Change in 2021. Efforts are being undertaken to achieve the target of 40 percent reduction in greenhouse gases (GHG) emissions by 2030, which under a Business as Usual scenario, is projected to be around 6,900 Gg¹ of carbon dioxide equivalent (CO₂-eq) in 2030.
- In 2023, the net GHG emission is estimated at 5,600 Gg CO₂-eq on a business-as-usual scenario.
- Around 80 percent of GHG emissions in Mauritius results from energy use, followed by the waste sector (11 percent). In 2022, GHG emissions from electricity generation decreased by 3.6 percent and increased by 9.6 percent in the transport sector compared to 2021.

Circular Economy and Solid Waste Management

- The Roadmap and Action Plan for Circular Economy was approved by Government in August 2023 in order to facilitate the transition to the Circular Economy. The roadmap focuses on 5 priority areas namely: (i) agri-food, (ii) construction and real estate, (iii) consumer goods, (iv) mobility and logistics and (v) waste management.
- Mauritius generates about 1,482 tonnes of waste daily. In 2023, the total volume of wastes disposed of at the Mare Chicose Landfill was 541,138 tonnes.
- Actions in the waste management sector have already been initiated to divert wastes from the landfill through the construction and operation of Regional Integrated Waste Processing Facilities on a Public Private Partnership basis. With the operation of these facilities, it is expected that around 200,000 to 250,000 tonnes of waste will be transformed into valuable end products.

Hazardous waste management

- Since the start of operation of the Interim Storage Facility for Hazardous Wastes at La Chaumiere, Bambous in April 2017, a total of around 3,484 tonnes of hazardous wastes were collected at the facility. Of these, around 2,714 tonnes comprised Heavy Fuel Oil (HFO)-contaminated wastes resulting from the MV Wakashio oil spill. The remaining 770 tonnes of hazardous wastes collected comprising hazardous chemical wastes, pharmaceutical wastes and waste gas cylinders were collected from more than 250 hazardous waste generators across the island for exportation to licensed recovery and disposal facilities in Europe.

Key Challenges

- Increase the resilience of coastal zones due to accelerated sea level rise and more frequent and intense cyclones
- Identify alternatives to plastic products to combat plastic pollution
- Inadequate resources for sustainable development and climate adaptation and mitigation
- Introduce enabling measures to allow the channeling of source-segregated waste to the Regional Facilities for recovery and recycling purposes
- Ensure the proper management of public beaches
