Disposal of Unserviceable Goods

Further to this Ministry's Circular No 9 of 2018 dated 23 October 2018, you are hereby requested to properly categorize the unserviceable goods and invite competitive bids for sale in line with paragraphs 15(c) and 18(b) of MOFED Circular No 17 of 2012, from recyclers (as per list given at Appendix I) as well as the general public, as a first step, towards their disposal. Interested bidders must, however, be issued with a bidding document, free of charge, (as per sample at Appendix II), and be requested to submit their respective bids within a period of two (2) weeks.

- 2. All unsold unserviceable items should thereafter be disposed of as solid waste in the manner described in the above-mentioned Circular No 9 of 2018.
- 3. The unserviceable goods may be categorized as follows:
 - (i) Tables office, conference etc;
 - (ii) Chairs executive, office, conference etc;
 - (iii) Sofa sets;
 - (iv) Filing Cabinets and Cupboards metal:
 - (v) Filling Cabinets and Cupboards wooden; and
 - (vi) Miscellaneous minor items, including tyres.
- 4. The invitation for bids should be posted on the Ministries'/Departments' websites as well as on the Public Procurement Portal, from where the document may also be downloaded. Supervising Officers may, however, note that the sale of unserviceable goods does not fall under the purview of the Public Procurement Act 2006.
