THE CUSTOMS TARIFF ACT Regulations made by the Minister under sections 3 and 15 of the Customs Tariff Act

1. These regulations may be cited as the Customs Tariff (Amendment of Schedule) (No. 3) Regulations 2003.

2. In these regulations-

"Act" means the Customs Tariff Act;

"item" includes the entries corresponding to the item.

- 3. The First Schedule to the Act is amended -
 - (a) in Part I -
 - (i) by deleting the items specified in PART A of the Schedule to these regulations; and
 - (ii) by inserting in their appropriate numerical places the items specified in PART B of the Schedule to these regulations;
 - (b) in PART II
 - (i) by deleting items E 17, E 20, E 23, E 24, E 34 and E 55; and
 - (ii) by inserting in their appropriate numerical places the items specified in PART C of the Schedule to these regulations;
 - (c) in PART II A -
 - (i) by deleting item A 2, A7, A 11, A 22, A 36 and A 54; and
 - (ii) by inserting in its appropriate numerical place the item specified in PART D of the Schedule to these regulations.
- 5. These regulations shall come into operation on 10 June 2003.

- (3) Materials when proved to the satisfaction of the Comptroller to be used exclusively in the manufacture of the EVA (ethylene-vinyl acetate) sheets or rubber sheets.
- (a) Sports footwear which has, or has provision for the attachment of spikes or studs; spikes and studs for such footwear.
- (b) Protective equipment and kimonos, specially designed for use in sporting activities.
