MISSION

Provide an efficient and effective system for the resolution of industrial disputes in order to promote harmony, equity and peace in the workplace.

STRATEGY

The Permanent Arbitration Tribunal (PAT) was set up in 1973 following the enactment of the Industrial Relation Act (IRA) 1973 to:

(i) Hear and arbitrate industrial disputes and other cases relating to industrial relations in the Civil Service, Public Enterprise and Local Government; and Private Sector, and make, interpret and enforce awards; and

(ii) Hear appeals from the decision of either the Minister of Civil Service and Administrative Reforms or the Minister of Labour to reject the report of an industrial dispute.

The Tribunal promotes harmonious relationship between employers and employees having regard to the need to:

(i) Relate increased remuneration to increased labour productivity;

(ii) Ensure the continued ability of the Government to finance development activities; and

(iii) Increase the rate of economic growth to provide greater employment opportunities.

The Tribunal can achieve diligent settlement of disputes by (i) laying more emphasis on conciliation and (ii) increasing number of hearings.
