#### **Mission Statement**

To ensure that the rights, needs and interests of children are given full consideration by public bodies, private organisations, civil society and individuals.

### **Strategic Direction 2016-2019**

- Promote compliance with the Convention on the Rights of the Child by proposing measures to ensure that the legal rights of children in care are protected.
- Sensitise and advocate to ensure that children, under the care of, or the supervision of a public body or other institutions, are treated fairly, properly and adequately and their rights are respected.
- Investigate cases relating to the situation of children in the family, in schools and in all other institutions, including private and public bodies, as well as cases of abandoned children or street children.

### Main Achievements for FY 2015/16

- 2,974 adults (parents, teachers, NGO leaders) and 900 children sensitised on the rights of the child and related issues.
- In-depth investigation on the Situation of Children in Reform Institutions carried out and a report, thereupon, published.
- Assessment report submitted on the state of children on the islands of Agalega and Rodrigues.
- Investigation unit restructured and new guidelines published for new investigation procedures.
- "Young ambassadors of the Ombusperson for Children Office" set up to involve young people through advocacy for the protection of the rights of children.
