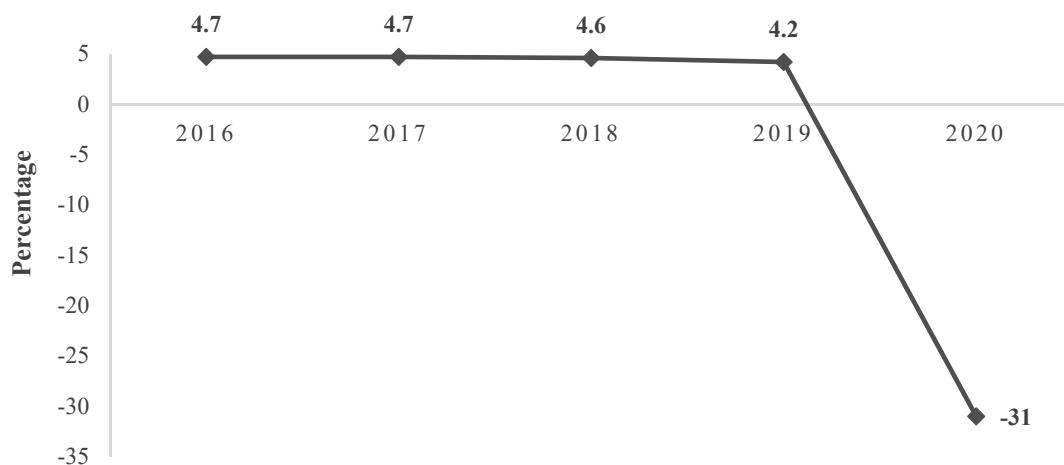
I. Mission Statement

To foster a balanced and harmonious Mauritian Society through consolidation of existing pluralism, cultural heritage and cultural values while promoting the creative industry.

II. Current Situation & Challenges

- In 2020, artistic and cultural activities were severely affected by the COVID-19 pandemic with the suspension of live performances, closure of cultural and heritage sites and cancellation of other cultural activities, resulting in a contraction of 31 percent in the sector.

Growth rate in the arts, entertainment and recreation sector



- Several relief measures have been put in place to support some 2,000 artists/performers in FY 2020/21, including the post-COVID-19 Relief Action Plan for the Creative and Heritage Sector and the COVID-19 Artists Support Plan 2021.
- A Digital Creative Art Scheme has been introduced under the National Arts Fund to support digital/virtual performances.
- As at May 2021, around 5,500 copyright owners (author, composer, musical arranger and publisher) were registered at Mauritius Society of Authors.
- The following heritage/historical sites have been rehabilitated during FY 2020/21:
 - La Tour Koenig
 - Ruins of World War II and French Batteries at Pointe du Diable
 - Lavoir and Abreuvoir at Mahebourg
 - Tour Hollandais at Vieux Grand Port

Key Challenges

- Development of a Public Art and Cultural Policy and a well-defined framework on creative sector
- Professionalisation of status of the artists and creation of a one-stop-shop to assist and promote local artists
- Reinforcement of the mechanism for the collection and distribution of royalties to artists
- Financial sustainability of small private museums
