

## **STRATEGIC OVERVIEW**


### **I. Mission Statement**

- To achieve a cleaner, greener, low-emission and climate change resilient economy
- To enshrine environmental conservation and protection in the culture of citizens and organisations
- To ensure the sustainable management of solid and hazardous wastes by adopting a circular economy approach focusing on waste segregation, resource recovery and recycling

### **II. Current Situation & Challenges**

#### **Greenhouse Gas Emission**

- In 2021, total Greenhouse Gas (GHG) emissions decreased to 5,000 Gg<sup>1</sup> of carbon dioxide equivalent (CO<sub>2</sub>-eq) from 5,780 Gg CO<sub>2</sub>-eq in 2019. Mauritius aims to reduce overall GHG emissions by 40 percent in 2030 compared to the Business-as-Usual scenario of around 6,900 Gg CO<sub>2</sub>-eq.
- The energy sector, accounting for 70 percent of total emissions, remains the largest contributing sector followed by the waste sector. Within the energy sector, electricity generating and transport industries were the two sub-sectors that contributed most of GHG emission.



#### **Integrated Coastal Zone Management**

- Coastal rehabilitation works of some 0.7 km from Pointe aux Feuilles to Grand Sable will be completed in this financial year and works are ongoing to rehabilitate around 4.6 km of eroded coastline in the south eastern region of the island. An additional 6.6 km of coastline is planned to be rehabilitated over the next 3 years.

### **Climate Change**

- Climate change has amplified the frequency of extreme events resulting in unprecedented rainfall intensity, acute flash floods and sea level rise with associated risks to life and damages to infrastructure and property.
- The sea level has been rising at an average rate of 4.7 millimetres (mm) per year over the past three decades at mainland Mauritius while the global average is 3.3 mm per year. During the period 2011-2020, annual rainfall decreased by 7.7 percent compared to the 1951-1960 decade. Studies show that Mauritius may become a water-scarce country by 2030.

### **Beach Management**

- The Beach Authority Act has been amended in May 2022 to improve enforcement in the management of activities on public beaches.
- Upliftment and landscaping works have been carried out at the Mont Choisy public beach to enhance facilities and minimise beach erosion.

### **Plastic Management**

- Plastic wastes account for more than 75,000 tonnes annually, predominantly composed of packaging (plastic bags and food boxes). Only around 3,000 tonnes of plastic wastes are recycled yearly, either locally or through exports. Following the promulgation of the Environment Protection (Banning of Plastic Bags) Regulations 2020, there are 451 manufacturers/importers registered for manufacturing/importation of biodegradable or compostable plastic bags/single use items.

### **Circular economy**

- Mauritius generates about 1,373 tonnes of waste daily. In 2021, the total volume of wastes disposed at the Mare Chicose Landfill was 501,167 tonnes, of which less than 3 percent is recycled. The new Solid Waste Management Strategy is shifting focus from the linear “take-make-waste” to a circular economy model with focus on resource recovery and recycling, to divert wastes away from landfilling.

### **Hazardous Wastes Management**

- Since its operation in April 2017, the Interim Storage Facility for Hazardous Wastes at La Chaumiere has collected some 513 tonnes of hazardous wastes from 230 hazardous waste generators. Approximately 301 tonnes were exported to licensed recovery and disposal facilities.

### **Key Challenges**

- Sea level rise and marine submersion resulting in accelerated beach erosion and degradation of coastal infrastructure and assets
- Capacity and financial constraints to mitigate and adapt to the negative impact of climate change
- Addressing behavioural change to encourage waste segregation and recycling
- Up to date national inventory of hazardous wastes to increase collection for disposal
