THE CUSTOMS TARIFF ACT

Regulations made by the Minister under section 15 of the Customs Tariff Act

1. These regulations may be cited as the Customs Tariff (Amendment of Schedule) (No. 4) Regulations 2007.
2. In these regulations -

"Act" means the Customs Tariff Act;

"item" includes the entries corresponding to the item.
3. The First Schedule to the Act is amended –
 - (a) in PART I -
 - (i) by deleting the items specified in Part A of the Schedule to these regulations;
 - (ii) by inserting in the appropriate numerical order the items specified in Part B of the Schedule to these regulations;
 - (b) in PART II -
 - (i) by deleting items E 47, E 54 and E 62;
 - (ii) by inserting in the appropriate numerical order the items specified in Part C of the Schedule to these regulations.
4. These regulations shall come into operation on 16 June 2007.
